





The "First statutes" and "First Ordinance" of Krishnaguru Adhyatmik Visvavidyalaya forwarded at Flag-'A' in your file No.AHE.11/2011 has been examined and following are observed :-

- ✓ 1. In the First Statutes, the short title may be written as "The First statutes of the Krishnaguru Adhyatmik Visvavidyalaya, 2018.
- ✓ 2. In the First Statutes, in chapter-II, in Para-I, in statute 2, there is a provision for Pro-vice-Chancellor, but, in Part-II the power and functions of the Pro-vice-Chancellor is not enumerated.
- ✓ 3. In the First Statutes, it is observed that there is no provision for the Governor of Assam. Hence, the post of "The Visitor" may be added.
- ✓ 4. In the First Statutes, in Chapter-III, in statute 10, the words "TERM OF THE MEMBERS.-" may be inserted as heading.
- ✓ 5. In the First Statutes, in Chapter-III, in statute 11, the words "FUNCTION OF THE FACULTY.-" may be inserted as heading by substituting the words "Subject to the provision of the Act, a faculty .-"
- ✓ 6. In the First Statutes, in Chapter-IV, in statute 14, in clause (5), the quorum for meeting of the Governing Body may be increased from 4(four).
- ✓ 7. In the First Statutes, in Chapter-V, in statute 18, in clause (3), the composition of Selection Committee is not enumerated.
- ✓ 8. In the First Statutes, in Chapter-V, in statute 18, in clause (11), in sub-clause (d), there is no paragraph 1(a) as stated.
- ✓ 9. In the First Statutes, it is observed that there is no provision for sensitization, prevention and redressal of sexual harassment in the working place. The Krishnaguru Adhyatmik Visvavidyalaya may be directed to form a committee or Body in this regard.
10. Further, minor mistakes that are observed in the First Statutes are corrected using pencil.

1. In the First Ordinances, it is observed that "Short title and commencement" and "Definitions" as to the terms used in the ordinance are not found to be enumerated.
2. In the First Ordinances, it is observed that ordinance No.2 and 3 are missing.
3. Further, the Higher Education Department may request the Krishnaguru Adhyatmik Visvavidyalaya to recast "The First Ordinances" in the line of the modified "The First Statutes" of the University and resubmit the same for our vetting.
